**A.** All products or services displayed and or sold from exhibits must be listed on application and pre-approved by Show Management. A photograph of unusual items or displays may be required for approval.

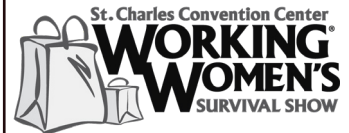
**B.** All Exhibits must be professional in appearance. No hand made signs are allowed.
